What You Need to Know (Complete ONE form for EVERY student attending)

Times: Your teenager should be at the Missouri Street Church of Christ building at 6:00am, November 7, 2020. We will depart at 6:30am. We will return on Sunday, November 8th around 3:00pm. Please ensure that your child is on time Saturday morning and has a ride home Sunday. Should an emergency arise and you need to contact your child, please call (901) 409-6861 (Dale Stewart Co-Youth Minister).

Cost: The cost is \$60 per student. Spending money isn't required or needed. The fee includes housing, five meals (over 2-day span), T-Shirt and transportation cost.

What to Bring: Bible, Journal, pen/pencil(s), good attitude, masks (for Covid-19 protection), clothes for 2 days, clothes & shoes that can get wet, toiletry items, necessary medicines, towel, sleeping bag, pillow, raincoat & flashlight.

What NOT to Bring: Shaving cream, fireworks, firearms, knives, alcohol products, tobacco products, any type of vape/vaping products, illegal substances, audio player, computers or gaming consoles. Disclaimer: Any and all items brought by an attendee are the sole responsibility of the attendee/owner. Missouri Street Church of Christ staff, volunteers, ministers, and leadership will not be held responsible for any items that are lost, stolen, broken or damaged during THE RIDGE CAMP.

Discipline: Any behavioral issues of any child that is not controllable by the chaperones, staff, ministers and leadership of the Missouri Street Church of Christ will be handled by contacting parent/guardian. We will request that you come and immediately take your child home.

Transportation: Every teenager attending will be required to ride in one of our vehicles. We will not allow any camper (7th-12th grade) to drive or ride with another student camper (7th-12th or college aged) to or from THE RIDGE CAMP.

I, the undersigned parent/guardian of _____, hereby expressly consent that my son or daughter can receive emergency medical treatment from any physician, hospital or other medical center without the necessity of them first notifying me. I further agree to hold harmless any chaperone, staff, minister or leadership of Missouri Street Church of Christ, physician, hospital or other medical center for rendering of such services. The Ridge Retreat and Adventure Center ROPES/TEAM CHALLENGE COURSE

Assumption of Risk, Release, and Indemnity Agreement

The Ridge Retreat and Adventure Center requires participants or parents of all participants to sign this Agreement to Participate, Assumption of Risk, and Release Form in order to be eligible to participate in the Program. The undersigned acknowledges an understanding of the following:

1. The Challenge Course includes a variety of activities including warm-ups, games, group initiatives, high and low challenge course elements, and other activities.
2. Although The Ridge Retreat and Adventure Center goal is to maintain the physical, emotional and social safety of each participant in Ridge Adventure Ropes & Retreats program, the physical, emotional and social risks must be assumed by each participant.
3. The level of participation in the Challenge Course program is voluntary and **“challenge by choice”** prevails at all times. No participant is required to do anything that he or she does not want to do. Certain information must be made known to the facilitators conducting the program so they are prepared to respond appropriately if the need arises. This information will be held in strict confidence. It must be provided to the The Ridge Retreat and Adventure Center staff prior to participating in the Ropes & Retreats program to maximize the safety for all.

******Please note that The Ridge Retreat and Adventure Center cannot make a medical determination regarding a person’s physical fitness to participate in challenge course activities. Only the participant and the participant’s parents/guardian, or participant’s physician can do that.***

I understand that the The Ridge Retreat and Adventure Center Ropes & Retreats program may be physically and emotionally demanding. I recognize and accept the risks involved in The Ridge Retreat and Adventure Center Ropes & Retreats program, and I assume the risks of physical and emotional injury that could result from these activities. In consideration of the above, I have and do hereby assume all of the risks of participation in the Ropes & Retreats program and will hold The Ridge Retreat and Adventure Center and Children’s Homes, Inc., its employees, agents, trustees, officers, and affiliates harmless from any and all liability, actions, causes of actions, claims, and demands of every kind and nature whatsoever, whether for bodily injury, property damage or loss or otherwise, which my child now has or which may arise from or in connection with my participation in The Ridge Retreat and Adventure Center Ropes & Retreats program. I, along with my family or heirs, understand and agree that we cannot sue The Ridge Retreat and Adventure Center and Children’s Homes, Inc., its employees, trustees, affiliates and associates, and if I do, I cannot collect any money. In addition, I will pay for The Ridge Retreat and Adventure Center attorney and court fees associated with any litigation I might bring against The Ridge Retreat and Adventure Center, its employees, agents, trustees, officers, affiliates and associates. I also state that neither I am nor my child (if I am signing on behalf of my child) is under or will be under the influence of any chemical substance including alcohol, either at the time of the signing of this Agreement or at the time of participating in the Ropes & Retreats program. I fully understand that my child's physical activity involves the potential risk of injury. I also understand that my child's participation in The Ridge Retreat and Adventure Center Ropes & Retreats program is entirely voluntary. I have written on the back of this form any physical, mental, or psychological issue my child may be experiencing and which could have an impact on his/her well being during the activities. I give permission to the adult sponsors for my child's group to discuss in confidence with the Ropes & Retreat facilitator these issues and to provide information which might have a bearing on his/her suitability with regard to the activities. I understand that this information is confidential and will only be discussed in private if completely necessary.

POLICIES AND REGULATIONS

Thank you for choosing The Ridge Retreat and Adventure Center as your "get-away". We hope you enjoy your stay here and find the facilities satisfactory. As a way of helping The Ridge and future Renting Groups, please familiarize this list to your group.

1. Christian character should be exhibited at all times by all persons.
2. Groups are expected to do a reasonable amount of clean up before their departure. Please leave the facility as clean as or cleaner than it was on arrival.
3. Tables and Chairs in the south storage room are for indoor use only and are not to be taken to the pavilions.
4. All equipment should be returned to the storage room when finished.
5. If food and drinks are taken to the pavilions, field, hiking trails or swimming pool, please pick-up trash. (No glass containers allowed in these areas)
6. No smoking, vaping, or use of tobacco is allowed on these premises. No Alcoholic beverages, nonprescription drugs, fireworks, firearms, or ATV's are allowed.
7. Do not write or mark on any part of the buildings or structures.
8. No one is allowed on Challenge Course elements without trained Retreat Center or Children's Home staff member present.
9. Before departure, please gather trash, inspect all buildings and grounds for cleanliness, personal items, turn off any lights and electrical appliances and lock- up.
10. Please only adults adjust thermostats
